BUPATI BONE,

- Menimbang : a. bahwa untuk melaksanakan ketentuan Pasal 96 ayat (5) dan Pasal 97 ayat (4) Peraturan Pemerintah Nomor 43 Tahun 2014 tentang Pelaksanaan Undang-Undang Nomor 6 Tahun 2014 tentang Desa, serta Pasal 12 ayat (8) Peraturan Pemerintah Nomor 60 Tahun 2014 tentang Dana Desa yang Bersumber dari Anggaran Pendapatan dan Belanja Negara, maka perlu ditetapkan Besaran Dana Transfer pada setiap desa dalam Peraturan Bupati;
- b. bahwa berdasarkan pertimbangan sebagaimana dimaksud pada huruf a, perlu menetapkan Peraturan Bupati Bone tentang Besaran Dana Transfer pada setiap Desa di Kabupaten Bone Tahun 2018;

MEMUTUSKAN :

Menetapkan : PERATURAN BUPATI TENTANG BESARAN DANA TRANSFER PADA SETIAP DESA DI KABUPATEN BONE TAHUN 2018

**BAB I
KETENTUAN UMUM
Pasal 1**

Dalam Peraturan Bupati ini, yang dimaksud dengan :

1. Daerah adalah Kabupaten Bone.
2. Pemerintah Daerah adalah Bupati Bone sebagai unsur penyelenggara pemerintahan Daerah yang memimpin pelaksanaan urusan pemerintahan yang menjadi kewenangan daerah otonom.
3. Bupati adalah Bupati Bone.
4. Kepala Desa adalah Kepala Desa di Kabupaten Bone.
5. Dana Desa adalah dana yang bersumber dari Anggaran Pendapatan dan Belanja Negara yang diperuntukan bagi Desa yang ditransfer melalui Anggaran Pendapatan dan Belanja Daerah Kabupaten dan digunakan untuk membiayai penyelenggaraan pemerintahan, pelaksanaan pembangunan, pembinaan kemasyarakatan, dan pemberdayaan masyarakat.
6. Desa adalah kesatuan masyarakat hukum yang memiliki batas wilayah yang berwenang untuk mengatur dan mengurus kepentingan masyarakat setempat berdasarkan asal asul dan adat istiadat setempat yang diakui dan dihormati dalam sistem Pemerintahan Negara Kesatuan Republik Indonesia.
7. Pemerintahan Desa adalah penyelenggaraan urusan pemerintahan dan kepentingan masyarakat setempat dalam sistem Pemerintahan Negara Kesatuan Republik Indonesia.
8. Pemerintah Desa adalah Kepala Desa dibantu Perangkat Desa sebagai unsur penyelenggara Pemerintahan Desa.
9. Badan Permusyawaratan Desa yang selanjutnya disingkat BPD adalah lembaga yang melaksanakan fungsi pemerintahan yang anggotanya merupakan wakil dari penduduk desa berdasarkan keterwakilan wilayah dan ditetapkan secara demokratis.
10. Pembangunan *Desa adalah upaya peningkatan kualitas hidup dan kehidupan untuk sebesar-besarnya kesejahteraan masyarakat Desa.
11. Keuangan Desa adalah semua hak dan kewajiban Desa yang dapat dinilai dengan uang serta segala sesuatu berupa uang dan barang yang berhubungan dengan pelaksanaan hak dan kewajiban Desa.

12. Pemberdayaan Masyarakat Desa adalah upaya mengembangkan Kemandirian dan kesejahteraan masyarakat dengan meningkatkan pengetahuan, sikap, keterampilan, perilaku, kemampuan, kesadaran, serta memanfaatkan sumber daya melalui penetapan kebijakan, program, kegiatan, dan pendampingan yang sesuai dengan esensi masalah dan prioritas kebutuhan masyarakat Desa.
13. Anggaran Pendapatan dan Belanja Negara, yang selanjutnya disingkat APBN, adalah rencana keuangan tahunan pemerintahan Negara yang disetujui oleh Dewan Perwakilan Rakyat.
14. Anggaran Pendapatan dan Belanja Daerah, yang selanjutnya disingkat APBD adalah suatu rencana keuangan tahunan daerah yang ditetapkan berdasarkan Peraturan Daerah tentang Anggaran Pendapatan dan Belanja Daerah.
15. Anggaran Pendapatan dan Belanja Desa yang selanjutnya disebut APBDesa adalah rencana keuangan tahunan pemerintah Desa.
16. Alokasi Dana Desa yang selanjutnya disingkat ADD, adalah dana perimbangan yang diterima Kabupaten dalam Anggaran Pendapatan dan Belanja Daerah Kabupaten setelah dikurangi Dana Alokasi khusus.

BAB II MAKSUD DAN TUJUAN Pasal 2

Peraturan Bupati ini dimaksudkan sebagai acuan bagi Kepala Desa dalam Pengelolaan dana transfer desa guna mendukung pembiayaan penyelenggaraan pemerintahan desa dalam melaksanakan pelayanan pemerintahan, pelaksanaan pembangunan, pembinaan kemasyarakatan dan pemberdayaan masyarakat.

Pasal 3

Peraturan Bupati ini bertujuan memberikan kejelasan dan kepastian hukum dalam pengelolaan dana transfer pada setiap desa.

Pasal 4

Dana Transfer untuk setiap Desa bersumber dari :
a. dana desa;
b. bagi hasil pajak dan retribusi daerah; dan
c. alokasi dana desa;

Pasal 5

Besaran dana transfer ke Desa Tahun 2018 sebesar Rp. 401.718.754.200,- (Empat Ratus Satu Milyar Tujuh Ratus Delapan Belas Tujuh Ratus Lima Puluh Empat Ribu Dua Ratus Rupiah), sebagaimana tercantum dalam lampiran yang merupakan bagian yang tidak terpisahkan dengan Peraturan Bupati ini.

Pasal 6

Dana Transfer sebagaimana dimaksud dalam Pasal 5, dianggarkan pada Anggaran Pendapatan dan Belanja Desa dan dipertanggungjawabkan kepada Bupati sesuai ketentuan Peraturan Perundang-undangan.

BAB III
KETENTUAN PENUTUP
Pasal 7

Peraturan Bupati ini mulai berlaku pada tanggal diundangkan.

Agar setiap orang mengetahuinya memerintahkan pengundangan Peraturan Bupati ini dengan penempatannya dalam Berita Daerah Kabupaten Bone.
